- FOR the purpose of clarifying the circumstance under which a former Councilmember who is receiving a service retirement allowance is entitled to a recalculation of their service retirement benefit; and generally relating to the Employees Retirement System.
- BY repealing and re-enacting, with amendments

12	receive a retirement allowance which shall be equal to one-twentieth of the member's average					
13	final compensation multiplied by the number of years of the member's service. No member may					
14	receive a retirement allowance in excess of sixty percent (60%) of the member's average final					
15	compensation after twelve (12) years of service, and no member may receive a retirement					
16	allowance in excess of seventy percent (70%) of the member's average final compensation after					
17	sixteen (16) or more years of service. NOTWITHSTANDING ANYTHING TO THE					
18	CONTRARY CONTAINED IN THIS SUBTITLE, A MEMBER WHO RECEIVES A

AND BE IT FURTHER ENACTED, that this Act, having been passed by

20 the County Council, shall take effect 45 days from the date of its enactment.
