The 2013-2014 Current Expense Budget Gifts and Grants Special Revenue Fund Coastal Communities Initiative

FOR the purpose of amending the 2013-2014 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from Federal funds made available to the County through the Maryland Department of Natural Resources Coastal Zone Management Program from funds awarded to the Chesapeake and Coastal Service of DNR by the National Oceanic and Atmospheric Administration.

WHEREAS, the National Oceanic and Atmospheric Administration has made an award of Federal funds available through the Maryland Department of Natural Resources

Coastal Zone Management Program to the Baltimore County Department of Public

Works, to be used to fund activities proposed under a Memorandum of Understanding to prepare an application for participation in FEMA's Community Rating System which provides the incentive of reduced flood insurance premiums for the target population, and related activities; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF
