The 2013-2014 Current Expense Budget Gifts and Grants Special Revenue Fund Weatherization - EmPOWER

FOR the purpose of amending the 2013-2014 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds made available to the County through the Public Service Commission of Maryland under the Maryland EmPOWER Energy Efficiency Act and managed by the Maryland Department of Housing and Community Development (DHCD).

WHEREAS, DHCD has made an award of state funds available to the Baltimore
County Department of Planning to be used to provide energy efficient, residential
improvements to low income Baltimore County households; and

WHEREAS, in accordance with Section 306 and Section 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended,

the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF
