A BILL
ENTITLED

AN ACT concerning

The 2014-2015 Current Expense Budget
Gifts and Grants Special Revenue Fund
Turner Station Strategic Demolition Grant

FOR the purpose of amending the 2014-2015 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from State funds made available to the County through Maryland Department of Housing and Community Development (DHCD) Strategic Demolition and Smart Growth Investment Fund for the Turner Station Strategic Demolition.

WHEREAS, DHCD has made an award of funds available to the Baltimore County Department of Planning to be used to demolish two (2) properties; 102 and 106 Avondale Road, Dundalk, 21222; and

WHEREAS, in accordance with Section 306 and Section 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended,

the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF
2 BALTIMORE COUNTY, MARYLAND, pursuant to the power and authority conferred
3 upon it by Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-
4 102 of the Baltimore County Code, 2003, as amended, that the Current Expense Budget
5 for the fiscal year ending June 30, 2015, be and is hereby amended by appropriating State
6 funds made available through a grant from DHCD to the Baltimore County Department
7 of Planning in the amount herein specified to the following program:

8 005-067-1547 Turner Station Strategic Demolition \$37,000

9 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been
10 passed by the affirmative vote of five members of the County Council, shall take effect
11 May 4, 2015.
