A BILL  
ENTITLED

AN ACT concerning

The 2020-2021 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
National Dislocated Worker Grant

FOR the purpose of amending the 2020-2021 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the U.S. Department of Labor through the Maryland Department of Labor - Division of Workforce Development and Adult Learning.

WHEREAS, the U.S. Department of Labor through the Maryland Department of Labor - Division of Workforce Development and Adult Learning has made an award of federal funds available to the Baltimore County Department of Economic and Workforce Development to be used to serve individuals who have been directly and/or indirectly impacted by the COVID-19 crisis; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306  
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County  
4 Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,  
5 2021, be and is hereby amended by appropriating federal funds made available to the Baltimore  
6 County Department of Economic and Workforce Development, in the amount herein specified,  
7 to the following program:

8 ~~005-052-2143~~ 005-087-2143 National Dislocated Worker Grant \$81,500

9 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been  
10 passed by the affirmative vote of five members of the County Council, shall take effect  
11 March 1, 2021 and will be retroactive to the commencement of the grant term on October 1,  
12 2020.
