ORDER OF DISMISSAL

The Applicant/Appellant, Allen Myers, did not appear, nor did anyone on his behalf.

Upon consideration of the fact the hearing Notice had the correct address and was not returned, and the fact there were no telephone calls to the Board advising of a problem connecting to the WebEx hearing, the Board will dismiss this matter. In the matter of: Allen Myers Case No.: CBA-25-014

IT IS THEREFORE ORDERED this 13th day of February, 2025 by the Board of Appeals of Baltimore County that the appeal filed in Case No. CBA-25-014 be and the same is hereby **DISMISSED WITHOUT PREJUDICE** for Failure to Appear.
