### New Election Office and Warehouse

Director LaVoie continues to follow-up with Property management and Duroun for the remaining items. The temporary generator was installed March 27, 2024. The permanent generator will be installed in August of 2024.

# Voter Registration (MDVOTERS)

All routine tasks, reports and monthly audits were completed on time and submitted to the State Board. The Critical Oversight Audit, ERIC Report, DHMH Report and Jury list, "Fuzzy" Reports for DHMH, Century Club and AOC were completed prior to the deadline. Voter Notification Cards, confirmation cards and change of address cards are mailed after new and changed registrations are processed. The voter registration deadline was April 23, 2024. The office remained open until 5:00 pm to serve voters. All required were completed. All deadlines were met.

# 2024 Presidential Election Cycle

The Notice of the 2024 Presidential Primary Election was provided as required on April 12, 2024. Staff continues to prepare for the primary election, packing supplies, etc. Supply verification for Early Voting and Election Day was conducted by two Board members on April 17, 2024

To date, almost 90,000 Baltimore County voters requested and have been mailed a mail ballot. As of April 21, 2024, approximately 19,00 have been returned by mail, in person or deposited in a ballot box. Ballots are processed and inventoried for canvass as soon as possible after receipt. Ballots are retrieved daily from all ballot boxes by bipartisan identifiable teams using County vehicles. The Mail in ballot Canvass will begin on April 24, 2024 at 10:30 pm in the Multipurpose Room of the Baltimore County Board of Elections. Director Lavoie partnered with County OIT to have all canvass activities livestreamed. The public is also permitted to observe the canvass in person.

# Election Equipment

The State required inventory is in progress due June 30, 2024. Logic and Accuracy Testing has been completed on all equipment that will be deployed on Primary Election Day as well as all reserve equipment that may be used on election day.

Director Lavoie and staff met with Property Management, Department of Aging and Recreation and Parks to outline the responsibilities for opening and closing the 11 early voting centers and the 243 polling locations on election day.

# Election Judge Recruitment, Information and Training

Election judge recruitment continues. We continue to have many republican election judge vacancies.
