New Election Office and Warehouse

There are several outstanding items to be completed in the new building. The AV installation has started and is expected to be completed within the next week. There was an additional delay in the installation of the partition walls in the multipurpose room and Board conference/Candidate Filing room. The new installation date is February 19, 2024. This date is a holiday, President's Day but Director Lavoie and Amanda White will be onsite to ensure the installation proceeds without issue. The completion of racking and shelving in the warehouse has not been scheduled as we are waiting for the vendor, Douron. We are also waiting on the remaining furniture items and replacement items from Douron to be delivered. Director Lavoie will continue to follow up with Property Management.

The front entrance lobby and warehouse entrance cameras are now connected to a monitor at the reception desk. The public use computer in the lobby is operational and available for citizens to complete online voter registration and updates, etc. to their voter record.

Election Agency Operating Budget, Fiscal Year 2025

Director Lavoie attended the mandatory "Budget Boot Camp" for Fiscal Year 2025 Operating Budget that was held on December 13, 2023. The FY2025 proposed budget begins July 1, 2024, and is in the development process. The target total budget provided by the County due to the unfunded State mandates that must be included. Director Lavoie will continue to work with the State and County Finance for credits back to the County on voting equipment, ballot box requirements and warehouse storage space. More information and Council Presentation dates to be provided at the March Board meeting.

Voter Registration (MDVOTERS)

All routine tasks, reports and monthly audits were completed on time and submitted to the State Board. The Critical Oversight Audit, ERIC Report, MDH Report, Jury list, "Fuzzy" Reports for MDH, Century Club and AOC we completed prior to the deadline. Letters, Voter Notification Cards, confirmation cards and change of address cards, etc. were mailed after new and changed registrations were processed.

"No Label" Petition

The State received petition signatures for the "No Label" petition on December 21, 2023 (the weekend before Christmas) which by law, gave us a deadline to complete processing the signatures by January 9, 2024. After the State logged in the pages, Baltimore County picked up the signature pages for our jurisdiction on December 22, 2023; however, we were not able to start the preprocessing or processing until the State completed their part of the process in MDVOTERS. Baltimore County began processing on December 26, 2023 and completed processing on January 5, 2024, returning the pages to State Board prior to the deadline. Staff with scheduled leave were not asked to work on planned days off. Appreciation is extended to everyone who worked together to meet this requirement and deadline without fail.

2024 Proposed Election Legislation

Director Lavoie is a member of both the MAEO Legislative Committee and Standards Committee. MAEO is closely watching proposed legislation and provided feedback insofar as process and fiscal notes. Director Lavoie submits all fiscal note and impact justifications to the County Administration and Budget Analyst. A complete listing of proposed election related legislation can be found at

Director Lavoie will attend the MACo Legislation Reception in Annapolis on January 24, 2024, representing both Baltimore County and MAEO.

2024 Presidential Election Cycle

Staff continues to prepare for the 2024 election cycle, including supply ordering and other tasks. As required by new legislation, all voters who have not requested a mail in ballot will receive a mail in ballot application prior to the Primary Election. Application mailing began last week on January 11, 2024. This has created a significant increase in our OLVR processing requirements and will also increase paper application processing in the office.

2024 Primary Election Ballot

The Baltimore County ballot candidates are being proofed in MDVOTERS. Certification of Ballot and Display of Ballot must occur on or before March 11, 2024. After certification, the final ballot will be provided to the Board.

2024 Ballot Box Security and Locations

The State Administrator approved the 36 Board approved Ballot Box locations. Director Lavoie is drafting the procedures that will be followed for ballot retrieval in 2024. The procedures will include bipartisan, identifiable ballot retrieval teams, security patrol between the hours of 5:00 pm and 7:00 am, and at least daily retrieval of ballots beginning on the day the boxes are delivered. The finalized procedures will be provided to the Board. Further, the contracts for ballot box security patrol were approved by the County Council in 2023 and are in place to begin on the day the boxes are delivered.

2024 Polling Places

The State Board approved the 243 polling place locations at their meeting on December 14, 2023. Voters affected by the three (3) changes were issued a new Voter Notification Card and letter explaining the relocation.

2024 Early Voting Locations

At its December 14, 2023 meeting, the State Board approved the eleven (11) Early Voting Center locations and the Board Action Notice was posted in accordance with law and regulation. The information and maps are posted on our website. The two (2) alternate early voting locations for 2024 will be the Owings Mills Library and Back River Community Center. The paperwork and documents are in process and will be submitted to the State Board this week.

Director Lavoie is working with the County to secure the necessary agreements between Towson University and the State Fair Grounds. All other Centers are located in County facilities and a MOU will be drafted and executed.

Staff continues to search for an alternative relocation space for the Reisterstown Senior Center to assist in the accommodation of meal distribution for the seniors during the Early Voting period.

In the past, Northminster Church hosted the seniors; however, the church is being sold and will not be available in 2024. More information to follow.

Election Judge Recruitment, Information and Training

Election judge recruitment is ongoing and appears to be successful with almost 2,750 election judges assigned for the Primary Election. A newsletter will be sent to all assigned election judges that will include important information and upcoming events. The Regulation that provides specific requirements to follow Election Law SB1200 has been finalized to include a \$100.00 per day of service bonus to returning election judges. This mandatory Regulation dramatically increases the election judge compensation budget.

The election judge manual is complete and has been delivered to the printer. The election judge training schedule will be provided to the Board. It is highly recommended for the Board to attend a training class. Train the Trainer will begin the 2nd week of February. Three (3) trainers from the State Staffing contract will assist with training. Classes will begin the week of February 12, 2024. The pollbook training database became available last week, and will be uploaded to the training pollbooks as soon as possible.

Election Equipment

Routine charging of all election equipment is current. Equipment allocation for deployment during the 2024 election cycle is being developed and will be available next week. Transportation and delivery of equipment schedule is being developed. A meeting with the transportation company will be held in March. More information to follow.

State required inventory process to begin soon. Staff will attend a refresher training on January 29, 2024.

New Ballot/Mail Sorting Equipment

Training and integration to MDVOTERS will occur over the next few months. The training scheduled for January 17, 2024 was cancelled due to inclement weather and will be rescheduled. Meetings with the State Board and the other 6 jurisdictions with the equipment will continue during the next few months which will help to plan for the MDVOTERS integration.

Voter Outreach and Education and Voter Registration Volunteer Training

Outreach, judge recruitment events and Voter Registration Volunteer training continue to be scheduled and conducted as much as possible.

New Pollbook Solution and New Printers

There is no new information on the new pollbook solution.

Procurement of New Voting System

The current lease with ES&S for the ballot scanners and ballot marking devices ends in 2025. The State is looking into options and will provide information when it is available.

Personnel

The recruitment for the Deputy Director position is in progress. The recruitment to fill 2 vacant State positions was submitted to the State Board on January 3, 2024. The recruitment posting has not yet been issued or posted on DBM website. Recruitment to fill the IT IV position was also sent to the State Board but the recruitment has not been posted on the DBM website.

Michael Webster filled a vacant contractual Election Program Assistant I position and his first day of service was January 3, 2024. Welcome back to Rena' Waggoner who filled the vacant contractual position. Her first day was January 17, 2024. Both employees will need to be administered the oath of office.

The recruitment for the 3 County temporary HR positions is going well. The interview panel selected 2 candidates and Director Lavoie is working through the hiring process with a start date of February 5, 2024. The 5 County temporary staffing positions will be filled by the first week in March. Performance Evaluations for all State employees were completed and submitted to State Board timely.
