### PUBLIC NOTICE OF CANVASS

Director Lavoie noted that public notice of the Mail in Ballot Canvass was provided and that the notice was provided by posting notice on the election agency website, on election agency social media platforms, on the bulletin board in the vestibule of the election office. Notice was also provided by mail through the USPS and electronically to the Baltimore County Democratic and Republican Central Committee Chairs and the State Board of Elections Administrator.

#### Canvassing of Ballots

Director Lavoie presented 12,500 Total ballots (10,200 Mail-In and 2,300 Web Delivery). Member Derick Johnson made a motion to accept and approve the opening and tabulation of the ballots. Member Albert Nally seconded the motion, and the motion passed unanimously. The canvassing of ballots resumed.

The Board of Canvassers ruled on whether to accept or reject any ballots that were referred to the Board from Day 1 and Day 2 of Canvass. At 11:10 am the Board of canvassers reviewed 20 ballots (13 from Day 1 and 7 from Day 2) all were accepted and held in a separate batch to be canvassed on another day.

A Correction of the Ballots presented was made by Director Lavoie to the Board of Cauvassers that the initial presentation of ballot total was 8,500, not 12,500. Secretary William Feuer made a motion to adjust the 1<sup>st</sup> presentation of ballots from 12,500 to 8, 500. Member Albert Nalley seconded the motion, and the motion passed unanimously.

At 4:04 pm 500 Web Delivery ballots were removed from Canvass to be held for the Provisional Canvass on May 22, 2024. A motion was made by Secretary William Feuer to reduce the number of Web Delivery ballots by 500 due to processing time. Member Albert Nalley seconded the motion, and the motion passed unanimously.
