

CAPITAL PROJECT CATEGORIES

The Parks, Preservation and Greenways capital budget is typically split into seven "project categories" through which individual projects are funded:

- P016 NeighborSpace
- P301 Recreation Facility Renovations
- P302 Athletic Field Construction/Renovation
- P307 Community/Neighborhood Park Development
- P309 Greenways/Stream Valleys/Trails Development
- P601 Park and Recreation Facility Acquisition
- P755 Park and Recreation Facility Accessibility





RECREATION FACILITY RENOVATIONS







This project category funds the largest number of projects from year to year, keeping parks and recreation facilities functional and safe. Numerous facility and amenity renovation and repair programs and project types are funded through this project, including:

- Playground repairs and replacement
- Tennis and multipurpose court renovations and repairs
- Waterfront facility repairs and renovations
- Small structure renovations, repair, and maintenance
- Sidewalk, steps, foot bridge, boardwalk repairs
- Parking lot and access road repair and re-striping
- Grounds repairs, such as correcting erosion issues and restoring grassy areas
- Repair and replacement of amenities such as park signs, fences, bollards, gates, picnic tables and grills, benches, drinking fountains, etc.
- Vandalism repairs
- Utility repairs and enhancements

ATHLETIC FIELD CONSTRUCTION & RENOVATIONS









P302 – Athletic Field Construction and Renovations funds projects and capital programs both large and small. This would include (but is not limited to):

- New field and ball diamond construction, including synthetic turf fields
- Field and diamond lighting system construction and renovations, including converting systems to LED, and replacing stolen wiring
- Backstop, safety fencing, and player bench renovation and replacement
- Large scale field and diamond renovations, including correcting drainage and erosion problems
- The annual ball diamond de-lipping program

CAPITAL PROGRAM CONTINGENCIES

212P302 – Athletic Field Construction and Renovations is one of multiple capital project categories for which "contingency" funding is budgeted. Contingency funds are, unlike other funding, not targeted to any specific capital project(s). Instead, they are budgeted to be able to address as-needed work – in some cases related to emergencies and/or safety issues – as well as serving as a safety net when project costs exceed cost estimates. The following athletic field, ball diamond, and field lighting system work was funded since the start of FY2024 through either P302 or P301 contingencies (listed costs are approximate):

- Eastern Regional Park Field Lighting Pole Replacements (\$1,548,000)
- Field Light Pole Inspection Services (\$71,000)
- Gough Park Field Lighting Wiring Theft Repairs (\$134,000)
- Hereford High School Rec. Center Stadium Field Lighting Repairs (\$55,000)
- Meadowood Regional Park Field Lighting Repairs (\$22,000)
- Northwest Regional Park Field Lighting Wiring Theft Repairs (\$151,000)
- Perry Hall Elementary School Rec. Center Field Lighting Pole Replacement (\$113,000)
- Reisterstown Regional Park Field Lighting Wiring Theft Repairs (\$310,000)










- Stansbury Park Path Repaving and Pond Area Renovations









RECENT PARK SITE ACQUISITIONS

Five properties acquired for park purposes since the start of calendar year 2024:


- Western Hills Park Addition: Approximately one-third of an acre purchased to acquire land on which part of a playground addition was inadvertently built.
- Anderson Property: ~9.2 acres of land near the end of Millers Island, purchased to serve as a future waterfront park.
- West Towson Park Addition: 0.5-acre parcel purchased to serve as an addition to West, providing additional space for park enhancements.
- 8212 Liberty Road: Approximately 5.8-acre property featuring a large structure, to serve as the future home of a new Randallstown Library and a large recreation center. Acquisition funded through Rec and Parks' capital budget.
- Bowleys Quarters Property: ~84.6-acre portion of the former Crane Power Plant Property, purchased to serve as a large waterfront park and anchor for proposed rail trail project.


